Connect 2022 Challenge Terms and Conditions

Thank you for being a part of Roblox! As we often say, Roblox is the Imagination Platform, the ultimate virtual universe where imagination rules. Key to that is your imagination and your participation. So, we are excited that you are taking part in the Connect 2022 Challenge Contest ("**Contest**"), which asks qualifying Roblox users (each an "**Entrant**") to Create a new game using Roblox Studio (each an "**Entry**").

- Acceptance of Terms. Below are the terms and conditions that govern your participation in the Contest ("Contest Terms"). These Contest Terms are supplemental to the <u>Roblox</u> <u>Terms of Use</u> ("General Terms") which govern your use of the Roblox websites or any Roblox products, software, applications, content, data feeds, and services ("Roblox Services"). The General Terms are incorporated herein by reference. If you do not agree to the General Terms and the Contest Terms, you may not participate in the Contest.
- 2) General Conditions. The Contest is open to Roblox registered users who are 13 years of age or older as of the Entry. Roblox employees, their immediate family members and persons living in the same household are not eligible. The Contest is void where prohibited or limited by law or where registration, bonding or localization is required. No purchase or payment is necessary to enter the Contest, and a purchase or payment will not increase the chances of winning. Chance of winning depends on the skill of each Entrant and the number of Entrants. If an Entrant is under the age of majority in his/her state or country of residence, the Entrant may only enter the Contest and is only eligible to win with the consent of the Entrant's parent or legal guardian. You further acknowledge and agree that by entering the Contest you are accepting a benefit that you cannot return or disgorge and that we are relying on your representations regarding your ability to accept and perform these Contest Terms, and you therefore waive any right you may have under applicable law to void, rescind, or otherwise avoid these Contest Terms. We reserve the right to confirm parental consent at any time by any manner, including by having the Entrant's parent or legal guardian sign a parental consent form. If you are a parent or guardian consenting to these Contest Terms on behalf of a child between the ages of 13 and 18, you additionally agree to guarantee and be fully responsible for that person's performance hereunder, including all financial obligations or liability he or she may incur, and all disclaimers and waivers of applicable legal protections provided herein, and you agree to take all actions (including executing such additional documents or agreements) necessary to effect and perfect the foregoing. In such cases, prizes will be awarded in the name of the Winner's (as defined below) parent or legal guardian. Any reference to an Entrant herein shall be deemed to include his/her parent or legal guardian, as applicable. In all other cases, you represent that you are 18 years or older and at least the age of majority in your jurisdiction of residence and fully competent to enter, and you hereby agree and acknowledge that you have read, understood, and agree to be bound by these Official Rules without modification

- 3) Duration of the Contest; Entry Methods.
 - a) Duration of the Contest. The Contest will run online from 04:59 PM Pacific Daylight Time ("**PDT**") on Friday, July 22, 2022 to 04:59 PM PDT on Sunday, July 24, 2022 ("**Contest Period**").
 - b) Entry Method. To enter the Contest:
 - (a) Create a new experience using Roblox Studio and upload it on Roblox within the Contest Period. The games uploaded to Roblox prior to Contest start day will not be taken into consideration.
 - (b) Create a video presentation of your Roblox experience.
 - (c) The experience must be created by a team. Each team may include a minimum of two (2) up to five (5) members.
 - (d) Submit the experience using the survey. Link to the survey will be provided on the Contest page ("Entry").
 - (e) You must submit your own Entry and not anyone else's. If you are caught posting anyone else's Entry you will be disqualified.
 - (f) Any Entry that is obscene, or anything that does not follow Roblox's <u>General</u> <u>Terms</u>, including <u>Community Rules</u>, will not be accepted.
 - (g) To be valid, all Entries must comply with these Contest Terms and Roblox's General Terms, and must be received no later than 04:59 PM PDT on Sunday, July 24, 2022.
- 4) Winner Selection.
 - a) After the end of the Contest Period, we will select twenty five (25) Best Entries and among these three Best Entries we will choose first place (1st Place), second place (2nd Place), third place (3rd Place) and fourth (4th Place) to twenty-fifth (25th Place) place award, each a "Winner". The Winners will be selected based on the following equally weighted criteria:
 - (a) <u>Theme</u>: Does your Entry include the proposed theme?
 - (b) <u>Creativity</u>: New ideas.
 - (c) Originality: Does the Entry contain assets created by the team?
 - (d) <u>Execution</u>: Quality of the Entry assets.
 - b) Potential Winners will be contacted via Roblox Developer Forum direct messaging around 5:00 PM PDT on Sunday, August 20, 2022. If a potential Winner is determined by us to be ineligible, unqualified to participate in this Contest, in violation of these Official Rules, or does not respond to our correspondence within 48 hours, the potential Winner may be disqualified and a new potential Winner may be selected under the same equally weighted criteria, if time permits.
- 5) Prize. The Winners will receive one item of their choice from the below list. If the Winner is a team each team member will receive the Prize. Each participant will receive a virtual accessory on Roblox.
- a) 1st Place Winner. Approximate market value Prize for 1st Place Winner is one thousand dollars (\$1,000).
 - i) \$1000 (USD) gift card of choice for purchasing electronics

- b) 2nd Place Winner. Approximate market value of Prize for 2nd Place Winner is six hundred dollars (\$600).
 - i) \$600 (USD) gift card of choice for purchasing electronics
- c) 3rd Place Winner. Approximate market value of Prize for 3rd Place Winner is four hundred dollars (\$400).
 - i) \$400 (USD) gift card of choice for purchasing electronics
- d) 4th to 25th Place Winner. Approximate market value of Prize for 4th to 25th Place Winner is one hundred dollars (\$100).
 - i) \$100 (USD) gift card of choice for purchasing electronics

Prizes are subject to availability and location. Roblox reserves the right to change the Prize at any time. If selected as a Winner, you agree to pay any taxes related to the prize required of you, and to provide the information necessary for us to facilitate payment of this prize. Failure to acknowledge receipt of your win, or provide your full name and address, within 48 hours of receiving notice of your win from Roblox (or within another claim period if specifically stated) may invalidate your Entry and we may pick an alternative Winner.

We reserve the right to correct any typographical, printing, computer programming or operator errors, including without limitation computer errors that erroneously award prizes.

We reserve the right in our sole discretion to disqualify any individual we believe to be tampering with the Entry process, the operations of the Contest or the Roblox website; to be acting in violation of the Contest Terms and the General Terms; or to be acting in an unsportsmanlike or disruptive manner, or with intent to annoy, abuse, threaten or harass any other person.
